Honorable Chairperson Evans, Members of the Coachella Valley Conservation Commission and CVCC staff:

At your last meeting on June 11, 2020 I spoke on behalf of the Bighorn Institute regarding the long awaited La Quinta fence project. My presentation summarized our letter of the same subject and included sheep mortality numbers. You'll recall a question came from the Commission asking for validation of those numbers.

At my request, Bighorn Institute staff then prepared the attached five page report for your consideration. Unfortunately, at the end of June, another ram drowned in Lake Cahuilla adding another urban death. Urban related mortalities from August 2012 to June 2020 total 33 Bighorn Sheep deaths. To be fair for comparison, non-urban deaths in the same timeframe total 11 bighorn sheep.

Urban and non-urban bighorn deaths are listed and detailed on the attached report, supported by maps and just a few photographs. If you have any questions please feel free to contact the Institute; as I've stated before we stand ready to assist the Commission and your staff in an effort to move this project to implementation. We all have the sheep's best interest at heart.

Rather than wait to present this information at your next meeting in September, we felt it was important to submit it now as a written report, and summarize it verbally for the record at your next meeting in September.

Thank you for the work you do, especially during these unprecedented pandemic times.
